The department was commended for its collegiality, excellent facilities, large and diversified grant portfolio, and supportive academic training that has significantly shortened the time to completion for a Ph.D. It faces challenges with growth management and uncertainty in long term funding. Recommendations focus on diversification of funding, hiring strategies, and communication around service obligations.
