## Welcome

Darryl Butt, Graduate School Dean, welcomed everyone
Proposal: To calculate undergraduate GPA across all undergraduate coursework rather than limiting it to coursework toward the completed Bachelor's degree.
Presenter: Brittany Baker-Brousseau, Senior Associate Director, Admissions
Discussion took place about:

- How "shadow" - combined undergraduate/graduate courses - will be accounted for in transcript evaluation
- How repeated courses are accounted for in transcript evaluation
- Why change is needed:
- Large number of applicants with undergraduate coursework from more than one institution
- Need to account for different international grading scales
- Accommodation for students with a WGU transcript that doesn't use letter grades
- More accurate representation of student undergraduate-level coursework
- This proposal is a modification of current procedures, not a change in policy.
- Council members would like to see this again in the spring following its implementation this academic year cycle.

## Proposal:

## New Program - Resilient Energy Certificate

Presenter: Milind Deo, Professor, Department of Chemical Engineering and Alan Walker, EGI Operations Manager

Discussion took place about:

- Opportunities and benefits for students with this credential
- Need for better learning outcomes rather than a list of topics as outcomes
- How students are assessed by external stakeholders
- Integration and interaction of non-matriculated students with graduate students
- Questions of what entity is providing credential
- Concern that the program is being advertised without approval
- Transferability of non-credited work to credited courses.
- Specificity of admission requirements

The following recommendations were discussed:

- Outcomes need to be revised. They are listed as topics, but they should state what students will be able to do and should be measurable. They could tie the outcomes to the program's CIP Code definition.
- They need to provide more details for the program's admission requirements. The admission statement misses some departments from which students could be admitted.
- There needs to be a list of prerequisites and/or skills that are required for admission.
- There is unauthorized advertising for this program that alternately refers to the program as an initiative, a certification, program, certificate - this is confusing. "Certificate" should be used exclusively and consistently.
- Need letters of support from U Connected Learning, the College of Science and the College of Social and Behavioral Science.
- Confusion about the entity awarding credit and granting the certificate - is it a center or a department?

Action: The Council agreed to table this proposal for reconsideration after recommendations have been addressed.

## Proposal:

## New Emphasis to Existing Degree - MS in Nursing with emphasis in Nursing Leadership

Presenters: Gillian Tufts, Associate Professor, College of Nursing and Teresa Garrett, Associate Professor, College of Nursing

Discussion took place about:

- Opportunities available to graduates
- Logistics of an online residency - who is evaluating competencies
- Terminology of leadership versus "management
- Scalability of program
- Need for more clarity on title of program: emphasis/track and new degree versus adding to existing degree
- Confusion about which requirements are specific to the leadership emphasis and which are for the MS in Nursing degree in general

The following recommendation was discussed:

- Proposal must be updated to ensure clarity of emphasis-specific features; and proper terminology should be used consistently used: "MS in Nursing with Emphasis in Nursing Leadership."

- Financial aid ramifications for undergraduate students being enrolled in graduate courses
- Need for master's level Instructional Design and Educational Technology (IDET) graduates
- Available resources for advising
- Availability of IDET programs in St. George
- The need for a degree map to show that students meet requirements to qualify for financial aid as they transition from undergraduate to graduate student status.
